Article II. Objectives

The TLC Brotherhood is organized for the following purposes and no other:

1. 2. To provide charitable assistance through endeavors that the membership may select from time to time. Financial assistance using TLC Brotherhood funds shall be limited to charitable causes or organizations and shall not inure to the benefit of any individual member of the TLC Brotherhood.
3. To honor the service of those described in Objective 1, and the memory of those who died or are missing in action as a result of their service.
4. To collect and preserve the history of the service of those described in Objective 1, and to promote public knowledge and understanding of this service through educational activities.
